

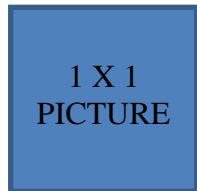

MEMBERSHIP APPLICATION and SUBSCRIPTION AGREEMENT

Sir/Madam:

I, _____, a resident of and/or working in the province of Bataan for at least Two (2) YEARS, apply & agree to become an associate member of OWDEE Multipurpose Cooperative (OWDEE Coop). I have completed the Pre-Membership Education Seminar (PMES) training course prescribed for prospective members and understood the Vision of the cooperative_ be the people's cooperative choice through its selected missions.

In connection with my application, I am submitting a copy of my PMES certificate and hereby pledge and agree to the following terms and conditions:

1. Pay the personal membership fee of One Thousand Pesos (P1,000.00) upon submission of this application. Membership fee is refundable in case of rejection, but no longer refundable if application is approved;
2. Upon approval of my application, pay the value of at least ONE (1) share and subscribe for at least Four (4) shares equivalent to Four Thousand Pesos (P4,000.00) at P1,000 per share to be paid on _____ or amortize with _____ (P _____) per month but fully paid within a year from date of my membership application approval. I shall actively participate in all cooperative programs, particularly in cooperative thrift and savings initiatives by continuously giving at least P100.00 a month for my capital share build-up and P100.00 monthly for my withdrawable-any-time savings mobilization;
3. Adopt and practice in life the following OWDEE Coop core values:
 - O-oneness with God in vision and leadership
 - W-whole-hearted respect for human dignity
 - D-discipline and dedication for the common good
 - E-extra ordinary environmental preservation
 - E-exceptional integrity & governance
4. I undertake to live by the cooperative core values, support & patronize Owdee products & services, comply with the provisions of this Agreement, its Articles of Cooperation & By-Laws, the operational policies, rules & regulations adopted by the Board and of the General Assembly, and of the CDA or any other government regulator. Failure on my part to do so, the OWDEE Coop at its option, may, after due process:
 - a) Fine;
 - b) Suspend; or
 - c) Expel me from membership where upon all my shareholdings shall be answerable for any liabilities including penalties or fines I may have with the cooperative, if not sufficient, pay them according to the policies set forth by its Board of Directors;
5. Attend in all invited meetings, trainings, seminars and civic or social activities as required by the Board of Directors and failure on my part to do so, accept the cooperative adopted corrective measure for my every absence unless previously excused by the Board and to make up for the activity I have missed; and
6. Enjoy the prestige, rights and privileges of becoming a member of people's cooperative choice __ the OWDEE Coop.
